Audit 2021/2022 Audit opinion – qualified

Except for the matters reported below in my Basis of opinion, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

Accounting Statement

In my opinion, the Accounting Statement does not properly present the Council's receipts and payments and financial position:

Line 3 – 2020-21. In 2020-21, the Council misclassified monies received from the county council as precept in line 2. The 2022-2021 comparatives have corrected this error but the comparative amounts show other receipts as £28,457. The correct amount is £10,457.

The Council is reporting unpresented cheque payments as a separate item in lines 6, 7, 9 and 11. These are reconciling items between the Council's cash book and its bank statement balance at 31 March, 2022. These mut not be reported in the annual accounts.

The Council has not provided sufficient explanation for the variances in its receipts and payments compared to the prior year.

Annual Governance Statement

In my opinion, the Annual Governance Statement is inconsistent with the Council's governance arrangements for the year:

Assertion 1: The Council states it made proper arrangements of the approval of the accounts. We are unable to confirm back to meeting minutes of when the accounting statements were approved.

Other matters arising and recommendations

There are no further matters I wish to draw to the Council's attention.
