#### **2649 - MINUTES**

#### 2650 - Public Question Time

3 members of the public had attended to discuss meetings that had been held regarding options for the Llandeilo by-pass. They were concerned regarding the options given for the routes of the by-pass, and the response of the Community Council. It was explained that all options were discussed at the April meeting and each member was given the opportunity to give an opinion on their preferred option. The plans and all options were discussed as to which option would have the least impact on the village of Ffairfach, schools were also taken into consideration. Everyone had been given an opportunity to attend the meeting at Llandeilo and complete a consultation document.

The members of the public present were concerned that one of the options chosen by the Community Council was going very near their property, and they stated that the Community Councillors should have gone around the routes for local opinion. Following a lengthy discussion they were going to contact their local M.P., A.M., W.A.G. and the Trunk Road Agency.
